Certificate is liable to be revoked by the Municipal Commissioner for Greater Mumbai if development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not accordance with the sanctioned plans.

The conditions subject to which the same is granted or any of the restrictions by the Municipal Commissioner for Greater Mumbai is contravened or not complied

Municipal Commissioner of Greater Mumbai is satisfied that the same is obtained by him through fraud or misrepresentation and the application and every person deriving benefit therefrom shall be deemed to have carried out the development work in contravention of section 43 or 45 of the Maharashtra Regional and Town Planning Act 1966.

Condition of this certificate shall be binding not only on the applicant but on his heirs, assigns, administrators and successors and every person deriving title through or

the Municipal Commissioner has appointed Assistant Engineer to exercise all powers and functions of the Planning Sub Registrar Borivali.
