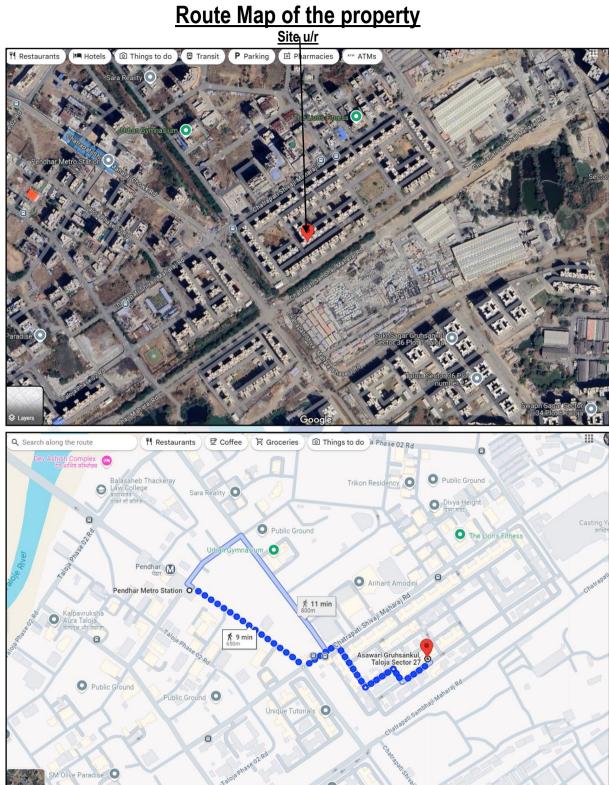

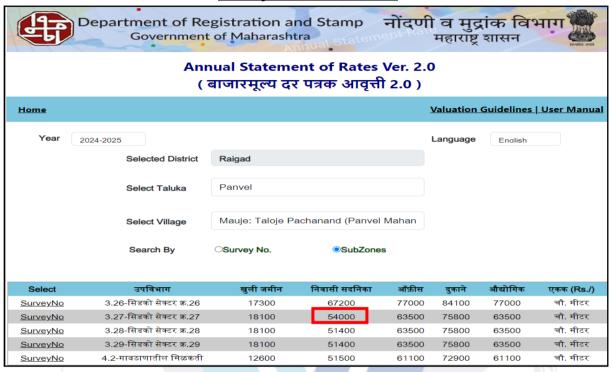
Note: The Blue line shows the route to site from nearest metro station (Pendhar – 650 mtrs.)

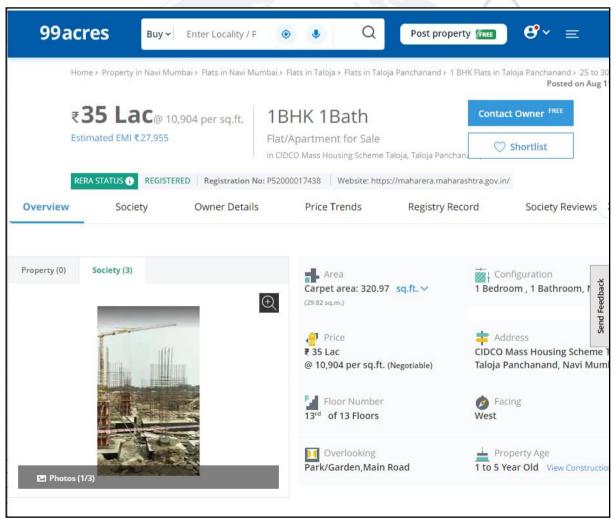

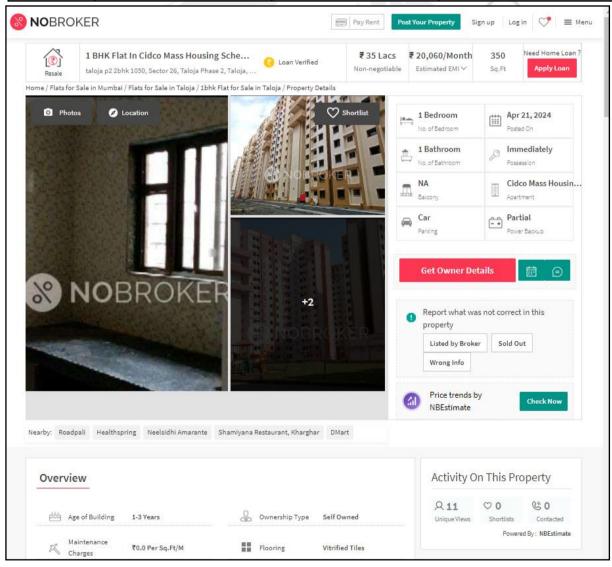
