2. We estimate Total Estimated Cost of completion of the aforesaid project under reference at **Rs. 20,00,00,000/- (Rupees Twenty Crore Only)** (Total of Table A and B) at the time of

The estimated Total Cost of project is with reference to the Civil, MEP and Allied works required for completion of the apartments and proportionate completion of internal & external works, as per specifications mentioned in agreement of sale and for the purpose of obtaining Occupation Certificate / Completion Certificate for the buildings/wings from **PANVEL MUNICIPAL CORPORATION** being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
4. The Estimated Cost Incurred till date is calculated at **Rs. 3,50,60,000/- (Rupees Three Crore Fifty Lakh Sixty Thousand Only)** (Total of Table A and B). The amount of Estimated Cost Incurred is calculated on the basis of input materials/services used and unit cost of these items.
