- 8) That all the condition mentioned in Supreme Court order dated 15.03.2018 regarding Dumping ground and condition mentioned in SWM NOC shall be complied with
- 9) That adequate safeguards are employed in consultation with SWM Dept. of MCGM for preventing dispersal of particles through air.
- 10) That the debris shall be managed in accordance with the provisions of Construction and Demolition Waste Management Rules 2016.
- 11) That the record of C & D generated & transported on designated dumping site shall not be maintained and uploaded on MCGM Auto DCR system.
- 12) The construction and Demolition waste shall be handled and transported to the designated unloading site as approved by E.E.(S.W.M.)
- 13) That the pending 1no of PAAA shall be submitted before Further C.C.
- 14) That the height of the building shall be verified from the competent authority before further C.C.
