Permission for trees felling, trimming & transplantation onplot no. C - 4/3

The Tree Authority of MIDC has approved the proposal for felling of 20 nos. of tree, transplantation of 00 nos. & trimming of 00 nos. of tree on the said plot. Drawing is attached herewith. You have also paid scrutiny fee amount of Rs. 7080.00 (SGST Rs. 540.00 + CGST Rs. 540.00) charges to MIDC vide demand ID no. 66412 dt. 13/03/2023 vide receipt no. GL23612529 Security Deposit amount of Rs.2,00,000.00 charges to MIDC vide demand ID no. 72603 dt. 12/07/2023 vide receipt no. GL24173291 dt. 15/07/2023

Permission of felling of 20 nos. trees & transplantation of 00 nos. trees is granted subject to following condition.

- 1) You have to fell the trees by planting additional trees with age of trees or more trees against approval given for felling trees. Neem-1, Shevga-2, Kanchan-1, Jambhul-1, kapur-4, Awala-2, Papda-1, Rai Awala-1, Ramfal-2, Fanas-1, Falsa-2, Vilayati Chinch-1, Badam-1, total 20 nos. of tree felling as shown in drawing.
- 2) You have to plant the new trees of same or native species with the age of trees i.e. 190 nos. Compensatory tree plantation of 190 nos. of trees is to be planted on same plot as proposed by the applicant. Ashoka- 190, total 190 nos. of tree as shown in drawing.
- 3) For every tree proposed for felling/ transplantation, trees of same variety or any other local or native variety shall be planted equal to the age of the trees proposed for felling / transplantation. Height of such trees to be planted shall be at least six feet. Each tree shall be geo-tagged. Such transplantation shall be carried out under expert guidance only.
- 4) The Security Deposit shall be refunded after three years. Subject to following conditions.

- i) It shall be the duty of applicant/owner to see the growth of trees and shall give the report to Tree Officer once in a six month about the condition of trees for a period of seven years.
- ii) In case of failure, the Tree Officer will initiate the action as per the Maharashtra (Urban Areas) Protection & Preservation of Tree Act (1975) as mentioned in affidavit & modified act on 16th Jan. 2017.
- 5) The felling & disposal of tree is at risk & cost of the applicant.
- 6) Whoever fells any tree or causes any tree to be felled in contraventions of the provisions of the act or without reasonable excuse fails to company with any orders issued or condition imposed by the Tree Officer or the Tree authority or voluntarily obstructs any member of the Tree Authority or the Tree officer or any Officers and Servants subordinate to him in the discharge of their functions under this Act, shall, on convection, be punished with the fine of not less than one thousand rupees which may extend up to five thousand rupees for every offence and also with imprisonment for a term of not less than one week.
- 7) The felling or causing of felling of each tree without the permission of the Tree Authority shall constitute a separate offence.

You are hereby directed to submit the photographs taken while transplanting of trees and the C.D. of the transplantation of the trees, so as to ensure proper transplantation of the tress.

No tree shall be fell/transplant until fifteen days from the date of issue of this letter.

As per Maharashtra (Urban Area) Protection & Prevention of Trees ACT, 1975 Section 8(6), 11(1) it is the duty of owner or occupiers of the land to preserve the existing trees. Permission of trimming of 00 nos. of tree is granted on basis of trees obstructing construction & to do the vertical development on the said plot. The allottee shall trim the trees for which Tree Authority MIDC has granted permission scientifically. The terms & conditions for scientifically trimming the 00 no. of trees approved for trimming are as below:-

- 1) Stem of trees & main branches of trees shall not be injured. You are responsible for any injury to trees as per Section (2) of Trees ACT, 1975.
- 2) Allottee shall see that there is no nest of birds or any habitant of wildlife on branches to be trim, You are responsible as per Wildlife Protection ACT, 1972.

- 3) Before trimming branches there shall not be any flowering, bloosming, and fruit bearing on the branches of trees. The action will be as per Environment (Protection) ACT, 1986.
- 4) Tree branches trimming shall be as per National Green Tribunal writ petition no. 156/2016 para no. 13.
- 5) Trimming of branches shall be with hack saw or any horticulturist equipment & Bodo paste (anti algae) shall be applied on trimmed affected area of branches.
- 6) No trees permitted for trimming shall be without leaves as per Trees ACT, 1975.
- 7) Trimming of trees permitted shall not be the cause of death of trees as per Trees ACT, 1975.
- 8) It is the responsibility of owner/occupier to trim the trees with own decision & own expenses required for trimming the permitted trees. The trimmed branches shall be disposed off at your risk & cost. The expenses shall be on your account for disposing the trimmed branches.
- 9) It is the responsibility to submit photographs of permitted trimmed trees within 7 days after trimming of trees.
- 10) No concretization/asphalting/ fixing tiles/paver blocks shall be permitted around the stem of trees within 1 mtr. dia. circle around trees.
- 11) No trees shall be trimmed until fifteen days from the issue of this letter.

 If you fail to follow the terms & conditions laid down as above and as per act of Maharashtra (Urban Area) Protection & Prevention of Trees ACT, 1975 the action under Section 21(1) will be initiated, Please note.
