  - (b) Any of the condition subject to which the same is granted or any of the restrictions imposed by the C E.O. (SRA) is contravened or not complied with.
    - (C) The C.E.O. (SRA) is satisfied that the same is obtained by the applicant through fraud or misrepresentation and the applicant and every person deriving title through or under him in such an event shall be deemed to have carried out the development work in contravention of section 43 and 45 of the Maharashtra Regional and Town Planning Act 1966.
- The conditions of this certificate shall be binding not only on the applicant but on his heirs, executors, assignees, administrators and successors and every person deriving title through or under him.

The C.E.O (SRA) has appointed <u>Shri. H. A. Masal</u> Executive Engineer to exercise his powers and functions of the Planning Authority under section 45 of the said Act.
