Permission is hereby granted under Section 45 of the Maharashtra Regional and Town Planning Act (Maharashtra Act No. XXVII of 1964) to Shri. Prabhakar K. ... of Village ... situated at ... on the following conditions viz:-

- 1. This certificate is liable to be revoked by the Municipal Commissioner for Greater Bombay, if (a) the Development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not in accordance with the sanctioned plan; (b) any of the conditions, subject to which the same is granted or any of the restrictions imposed by the Municipal Commissioner for Greater Bombay is contravened or not complied with; (c) the Municipal Commissioner for Greater Bombay is satisfied that the same is obtained by the applicant through fraud or misrepresentation and the applicant and every person deriving title through or under him in such an event shall be deemed to have accepted and the development work in contravention of Section 45 or 45A of the Maharashtra Regional & Town Planning Act, 1966, the Municipal Commissioner has appointed Shri. J. I. ... Executive Engineer, to exercise his powers and functions of the Planning Authority under Section 45 of the said act.
- 2. This Communicatory Certificate is valid for a period of one year from the date hereof and will have to be renewed thereafter.
- 3. This Communicatory Certificate is renewable every year but each extended period shall in all cases exceed three years, provided further that such license shall not be any subsequent application for fresh permission under section 44 of the Maharashtra Regional & Town Planning Act, 1966.
- 4. The conditions of this certificate shall be binding not only on the applicant but also his heirs, successors, executors, administrators and assigns and every person deriving title through or under him.
