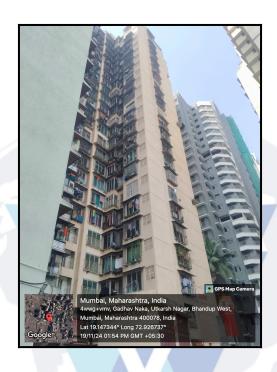

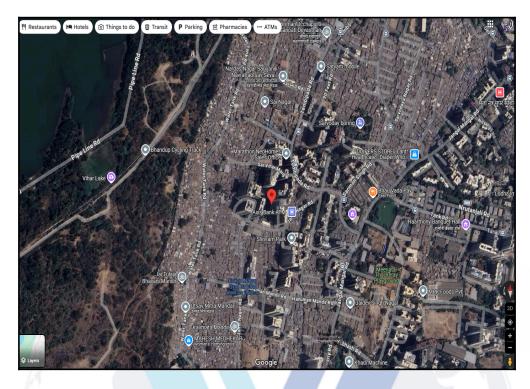




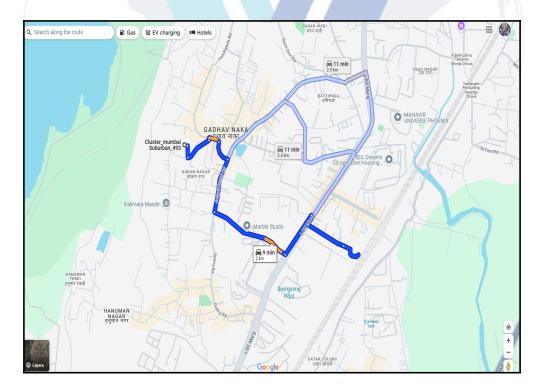




Route Map of the property



Note: Red Place mark shows the exact location of the property



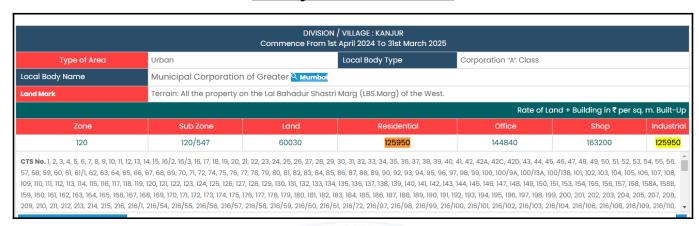

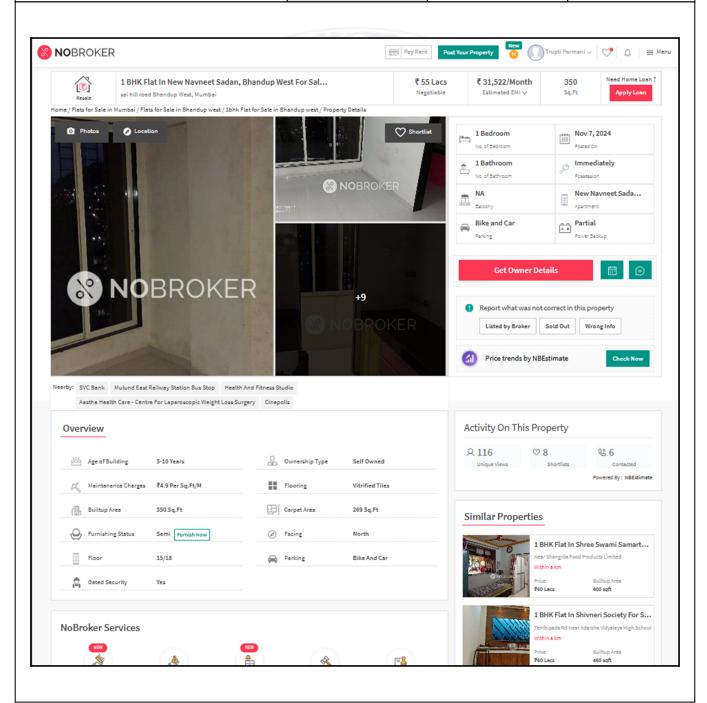

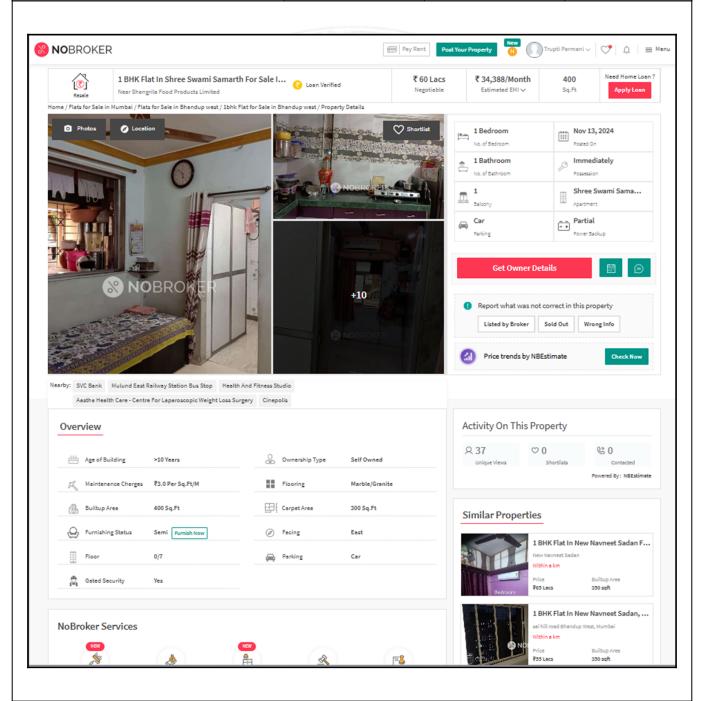
