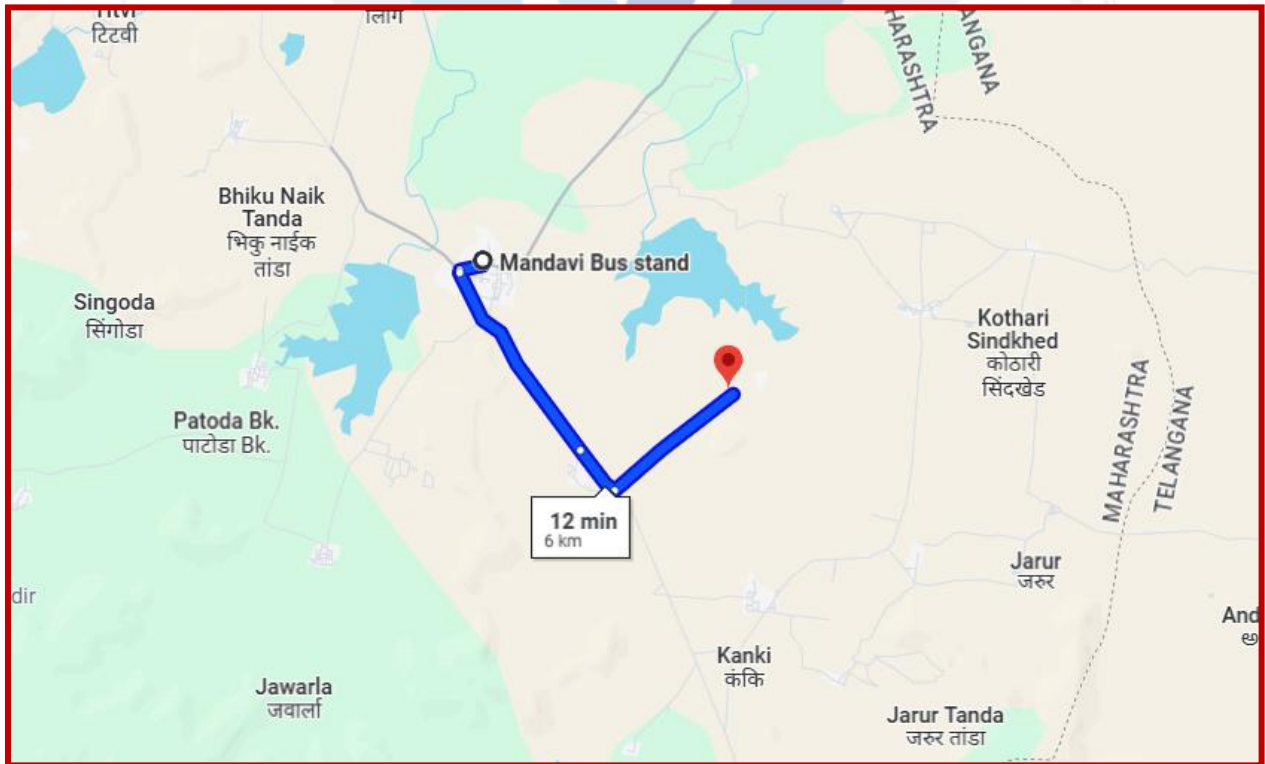
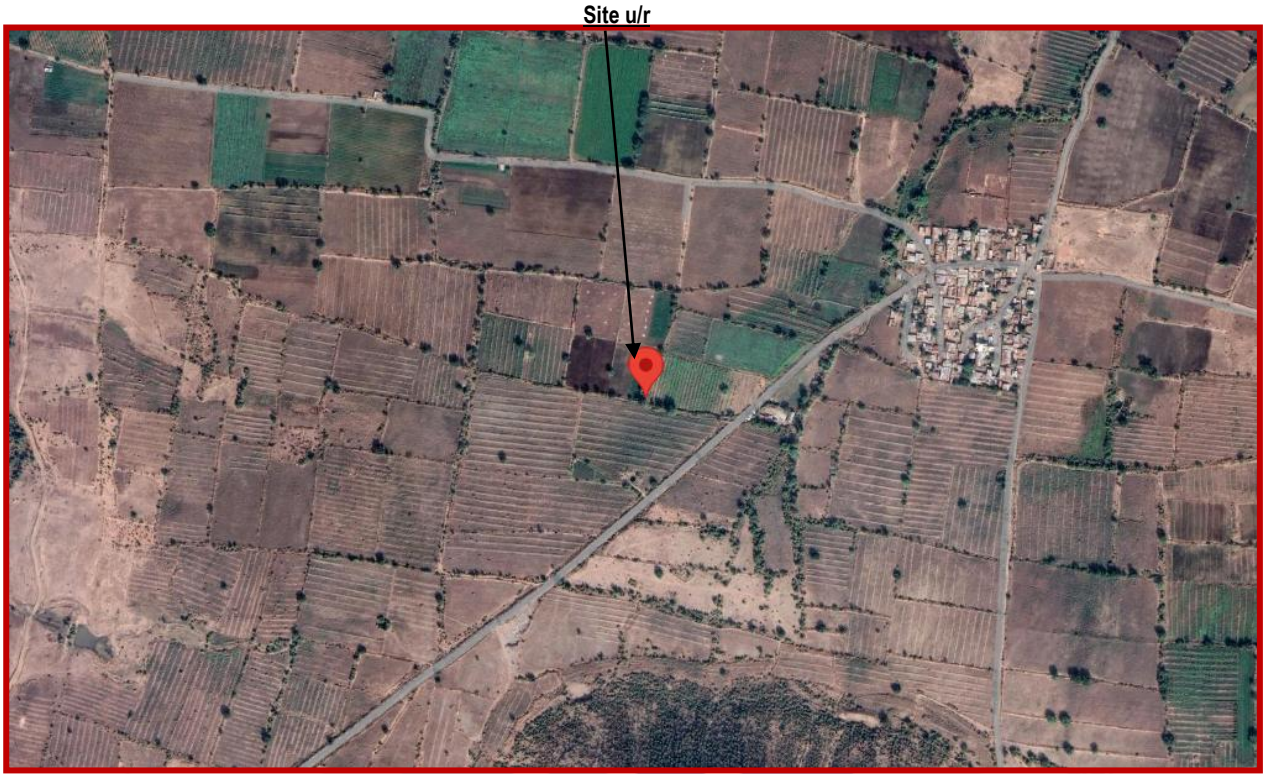

Information Management
