3) This consent is restricted to the transfer and assignment of the said Lease in favour of the Transferee(s) alone and in case the Transferee(s) propose/s to make any further transfer or assignment or parting wholly or partially with the possession of the plot of land demised under the said lease or any part thereof the Transferee(s) will have to make a fresh application for consent.


