The Party of the Second Part shall be bound from time to time to sign all papers and documents and to do all other things as the Party of the First Part may require him/her/them to do from time to time for safeguarding the interest of the Party of the First Part and or other Purchasers of Flat/Room/Shop in the said building. Failure to comply with the provision of the clause will render this Agreement ipso facto void and the earnest money paid by the party of the Second Part shall stand forfeited to the Party of the First Part.
- 18. The Party of the Second Part hereby covenants to keep the Flat/Room/Shop Walls, and partition wall drain pipes and appurtenances there te beloning in good tenantable repair and condition and in particular so is to support, Shelter and protect the parts of the building other than his/her/their Flat/Room/Shop.


