Note: The Blue line shows the route to site from nearest railway station (Panvel – 15.7 km.)

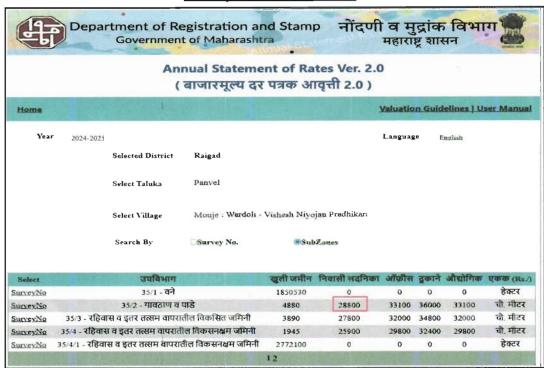
