7.1 **Procedure for Taking Possession-** The Promoter, upon obtaining the occupancy certificate shall offer possession of Apartment to Allottee through an email or notice in writing. Upon receipt of such email, the purchaser shall make full and final payment of the charges payable under this Agreement. Upon receipt of said charges, the Promoter and Allottee shall execute Deed of Apartment and Undertaking to be executed by the purchaser. Upon execution and registration of Deed of Apartment, the Purchaser shall submit the undertaking. Thereafter, the Promoter shall issue a possession letter. The said procedure will have to be strictly followed without seeking any concessions.

7.2. The Allottee shall take possession of the Apartment within 15 days of intimation given by Promoter through an email or notice in writing intimating that the said Apartments are ready for use and occupancy

7.3. **Failure of Allottee to take Possession of Apartment:** Upon receiving a written/Email intimation from the Promoter as per clause 7.1, the Allottee shall take possession of the Apartment from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement, and the Promoter shall give possession of the Apartment to the allottee. 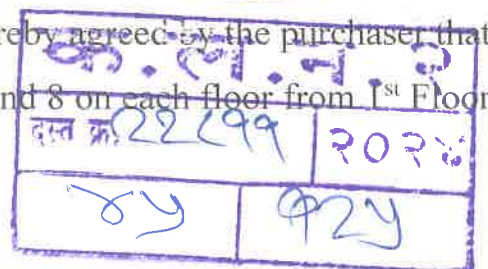

13 D. The Purchaser shall pay an amount of **Rs.99,000/-** (excluding GST) towards lumpsum maintenance payable for the period of 3 years commencing from the date of issuance of Occupancy certificate. Upon receipt of Occupancy certificate, the Promoter shall within 7 days offer possession of flat through email/or notice in writing. Though for completing the formalities of payments, execution of Deed of Apartment, undertaking, issuance of possession letter etc may take some time, the maintenance amount shall be payable from the date of occupancy certificate.
