You shall be placing this order on us on cost basis (without margins), and will be releasing payments towards advances and while collecting the material from our suppliers. You can opt to make direct payments to our supplier or to us, as they may prefer to. You will arrange transportation of these items upto the site. By doing so, you will be getting these items on cost basis, and will be actually saving on margins towards our financing cost and profit. 		
	Alternatively, you can keep the items under SCOPE 'B' with you, by placing orders on standard / regular suppliers of your choice. In such case, savings / additional costs will be to your account. You will also arrange transportation of these items upto the site. We will submit the detailed BOM / manufacturing drawing, you may arrange it directly.

Just in case, you opt to have one single scope [SCOPE 'A & SCOPE 'B' together] and have common payment terms, we are open to it, in such case, margin of 20 % on SCOPE 'B' items shall be charged extra towards our overheads, internal transports, financing & profit.

PRICE BASIS:

Prices are ex-works / ex-sub-supplier's works, unpacked. Packing, forwarding, taxes & duties (if applicable) will be extra to your account.

FREIGHT & INSURANCE:

TERMS OF PAYMENT:

DELIVERY PERIOD:

8 -10 months from the date of receipt of technically and commercially clear order and advance payment, whichever is later. The delivery period is given in good faith and is subject to force majeure clause.

GUARANTEE:

We guarantee the materials against any design / material / manufacturing defects for a period of 12 months from the date of commissioning or 18 months from the last date of major dispatch, whichever is earlier. Our guarantee excludes normal wear and tear and excludes any damage due to bad usage or reasons beyond our control.

During the guarantee period, if performance of the Furnace is below par due to reasons available to the guarantee clause, we will rectify / repair / replace the defect / defective part.

DESIGN STANDARDS:

The equipment and materials will be in accordance with the relevant standards of the Bureau of Indian Standards. Wherever Indian Standards do not exist, components will be designed, assembled and tested in accordance with the modern practice prevailing in the field.

VALIDITY:

Our offer will remain valid for your acceptance for 30 days from the date of this offer and thereafter will be subject to our confirmation.
