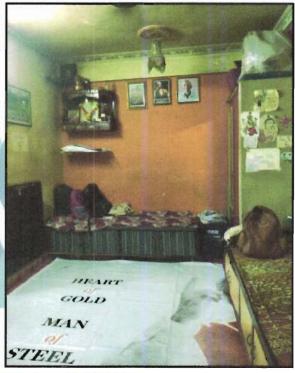

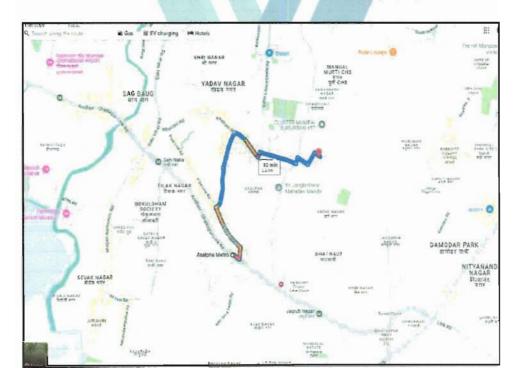




Route Map of the property

Note: The Blue line shows the route to site distance from nearest Metro Station (Asalpha - 2.2 Km.).

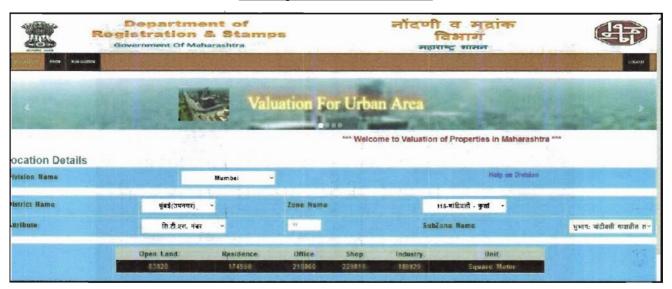

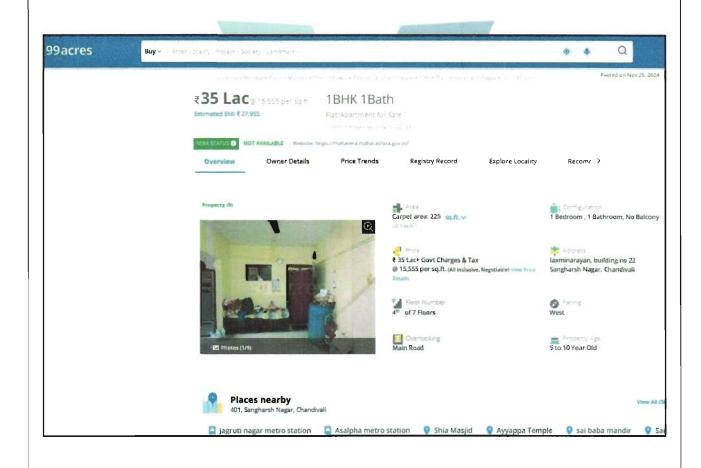

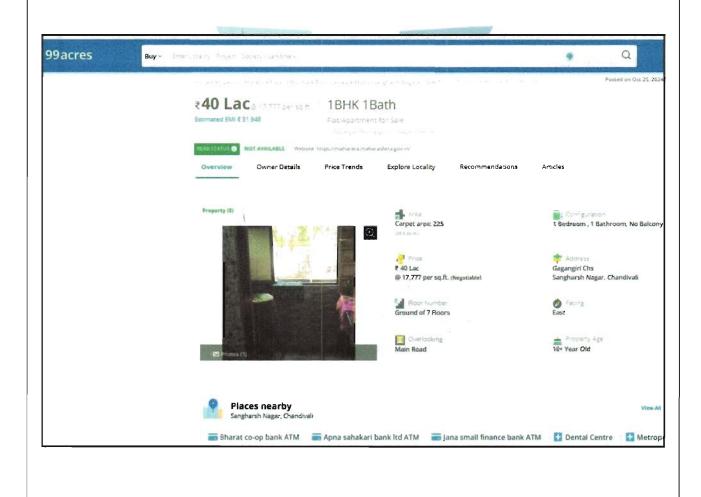
