The schedule of items and quantity required for the entire work as calculated by N.A. Quantity Surveyor\* appointed by Developer/Engineer, the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us to ascertain / confirm the above analysis given to us.

3. We estimate Total Estimated Cost of completion of the aforesaid project under reference at Rs.4,40,00,000/- (Total of Table A and B)at the time of Registration.
