Sir,

A building or part of the building is constructed on **CTS No.12(pt), Village Kurla, Bldg No-38, Neharu nagar, Shiv Vaibhav CHSL, Neharu Nagar Kurla (E), Mumbai.** At afore said address in respect of which, you have applied for permission to construct the same on **FB/HR/RV/154 dtd. 18.11.2013, FB/HR/RV/17 dtd.13.11.2020** u/sec.11(1) of Maharashtra Fire Prevention & Life Safety Measures Act, 2006, Fire service fee is leviable in respect of the aforesaid construction and amount of such fee shall be payable by you. As per State Government Notification No. FFS.2012/C.R.42/UD-20 dtd. 03.03.2014, the said fee is required to be as per Schedule -II, mentioned in the Act. As per Notification, you are liable to pay an amount of **Rs. 127170/- of total gross built up area 8478 sq.mtrs** towards Fire Service Fee.
