



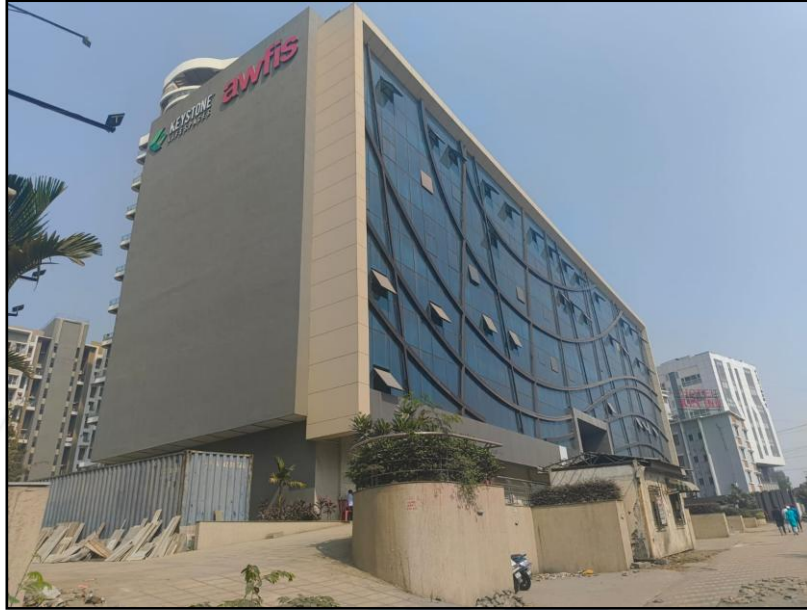

Justification for price /rate

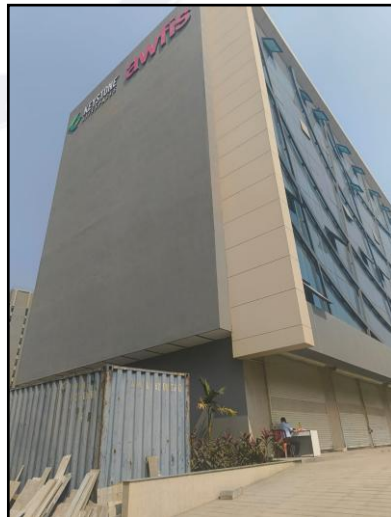
