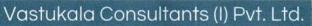
















# Route Map of the property

Note: The Blue line shows the route to site distance from nearest Railway Station (Kalwa - 2.6 km.).



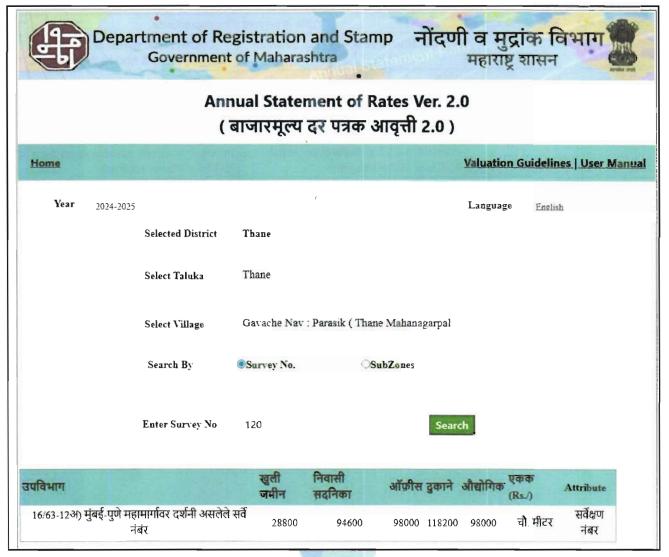
