## Justification for Price / Rate

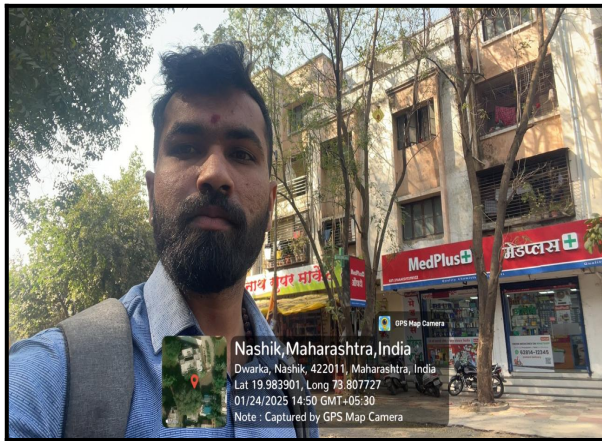

## Method of Valuation / Approach

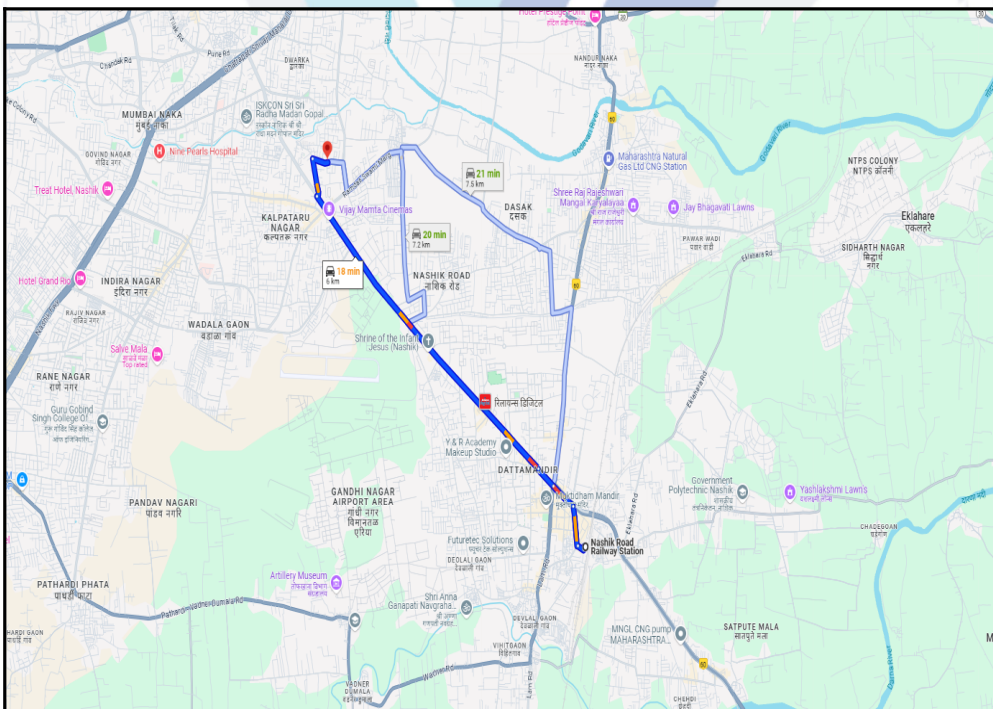
