





(1) Subject to the provisions of subsection (2), an executor or administrator has power to dispose of the property of the decoased, vested in him under section 211, either wholly or in part, in such manner as he may think fit,

- (2) If the deceased was a Hindu, Mohamadan, Buddhist, Sikh or Jain or an exempted person, the general power conferred by sub-section (1) shall be subject to the following restrictions and conditions, namely:
