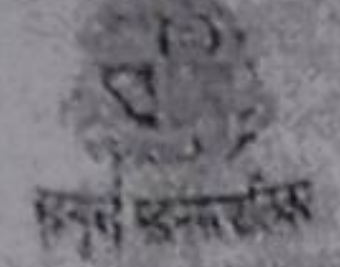


LOWER GROUND FLOOR PLAN
