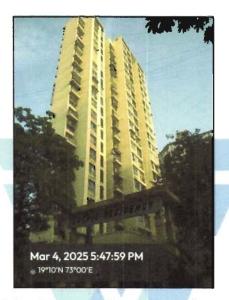

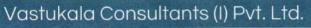

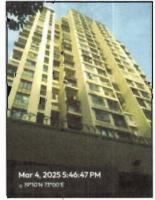

Note: The Blue line shows the route to site from nearest railway station (Ghansoli – 3.1 Km.)



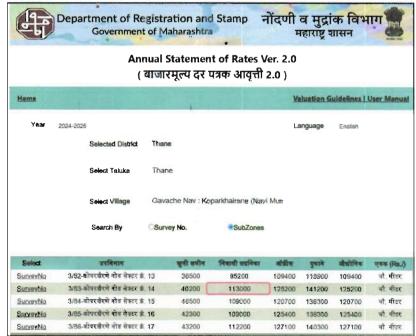

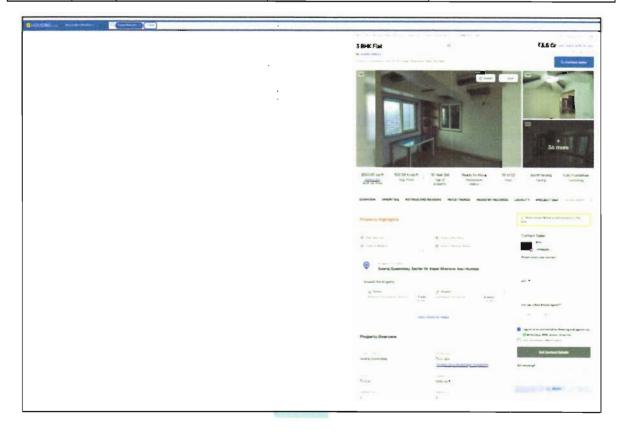

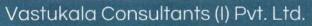
