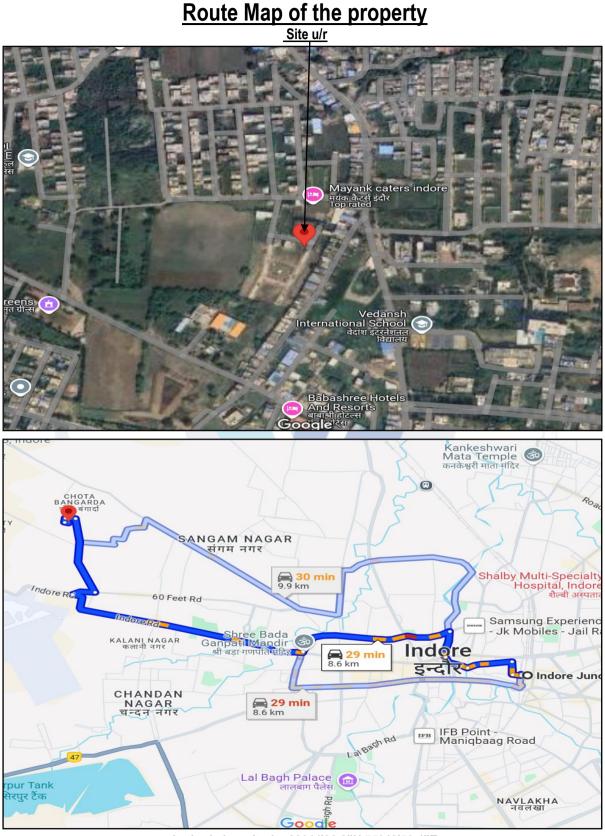

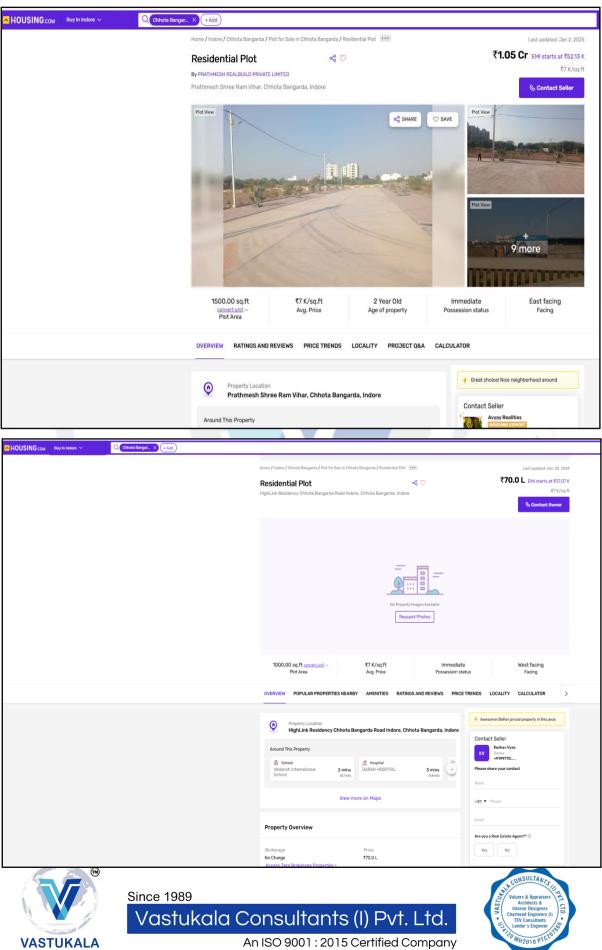

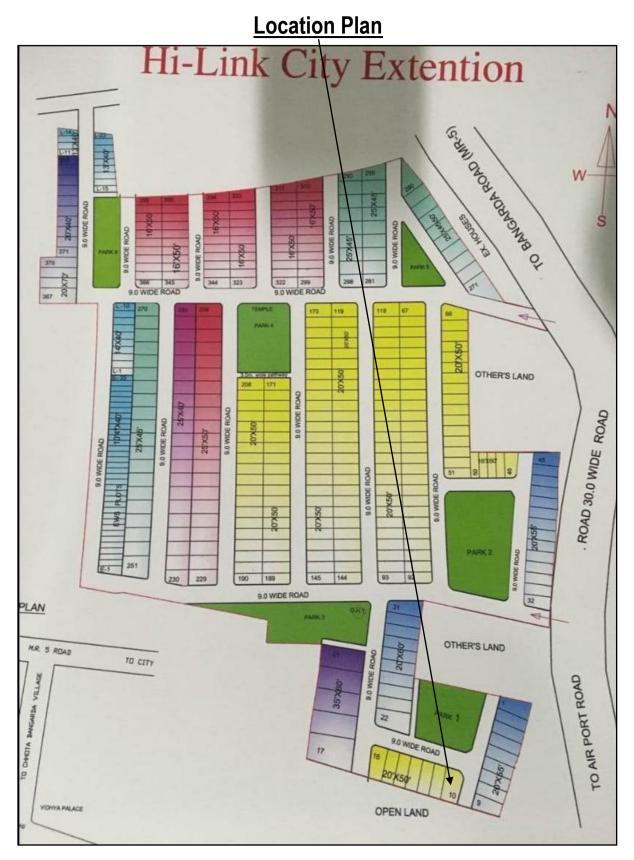

# MODEL CODE OF CONDUCT FOR VALUERS

# {Adopted in line with Companies (Registered Valuers and Valuation Rules, 2017)}
