- (g) The copies of certificate of Title issued by M/s.Shah & Sanghavi, Advocates, Solicitors & Notary of the Promoters, copies of property card showing the nature of the said property on which the flats are to be constructed and the copy of the plan of the flat agreed to be purchased by the Flat Purchasers approved by the concerned local authority have been annexed hereto and marked "C" to "E" respectively.
