We have estimated the cost of Civil, MEP and Allied works required for completion of the apartments and proportionate completion of internal & external works of the project as per specifications mentioned in agreement of sale. Our estimated cost calculations are based on the drawings/plans made available to us for the project under reference by the Developer/Consultants. The schedule of items and quantity required for the entire work as calculated by Quantity Surveyor appointed by Developer/Engineer, the assumption of the cost of material, labour and other inputs made by the developer, and the site inspection carried out by us to ascertain/confirm the above analysis given to us.

We estimate Total Estimated Cost of completion of the aforesaid project under reference at Rs. 409,98,12,736/- (Four Hundred and Nine Crore Ninety-Eight Lakh Twelve Thousand Seven Hundred and Thirty-Six Only) at the time of registration.
