Sub: EXTENSION OF SERVICES OF PANEL VALUERS

- Please refer to the Policy on Stock Audit, Valuation of Properties, Engagement of Collateral Management Agency, Techno Economic Viability & Lenders Independent Engineers and Empanelment 2024-25, issued vide IC No. 04546-2024 dated 30th Jan 2024.
- 2. As you are aware that, at present bank has following empanelled valuers,
 - 1502 No of valuers were empanelled & communicated vide Lr. No MSME:1617:2021, dated 01-10-2021 which is valid up to 30.09.2024.
 - In addition of above 1366 No of valuers were further empanelled and communicated vide Lr. No: MSME:4513:2022, dated 31-10-2022 which is valid till 30.09.2025.
- 3. To harmonise the process of renewal and making uniformity amongst panel valuers, the competent authority has approved to extend validity of those valuers empanelled in 2021 for further period of one year i.e. till 30-09-2025.
- 4. In line with the above now all the panel valuers as per Annexure-I are now valid till 30-09-2025.
- 5. Since annual performance reivew of all panel valuers is under process, in case any negative information/remarks received from any branch/office during review and/or at any stage during tenur of empanelment, the valuer will be removed from banks panel and will be intimated.
- 6. IBAs caution list of TPEs should be verified periodically. In the event of appearance of any of our panel valuers name in the IBA's caution list of TPEs, the details thereof shall be intimated to MSME Department CO, for appropriate action.
- 7. ZOs/ROs to ensure that there should be equal distribution of work amongst panel valuers based upon their past performance.
- 8. The present list supersedes all other previously issued empaneled valuers list.
