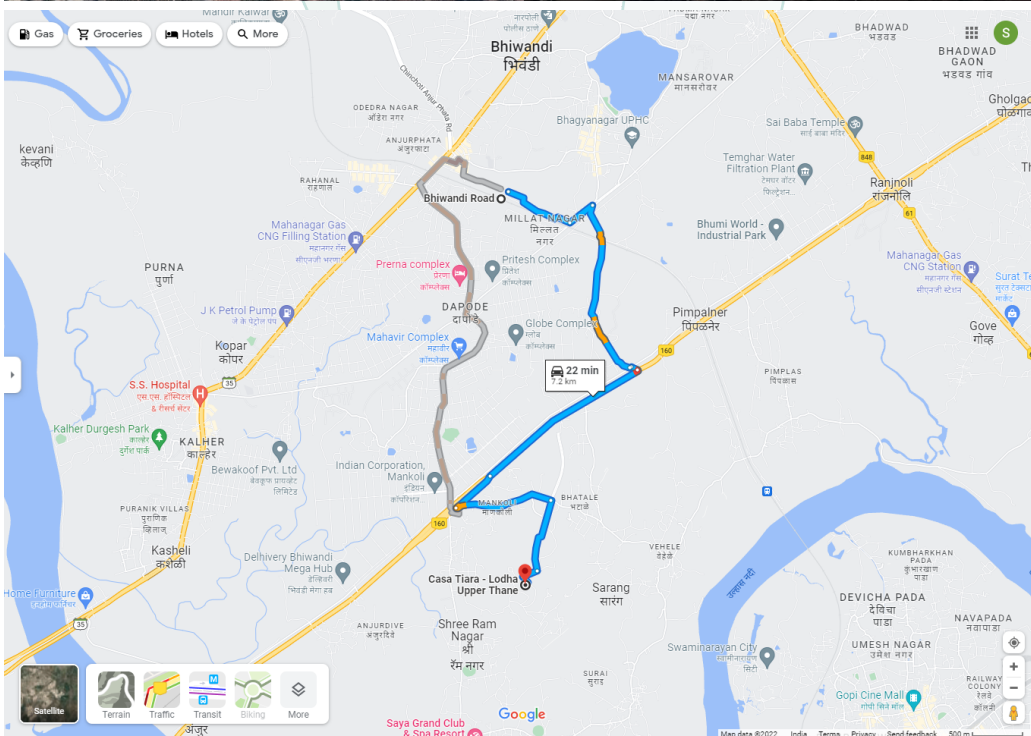

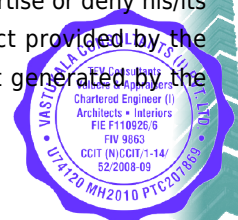
MODEL CODE OF CONDUCT FOR VALUERS
