### Route Map of the property

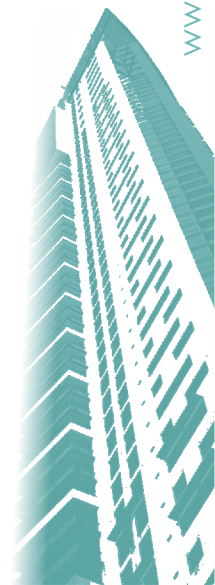
