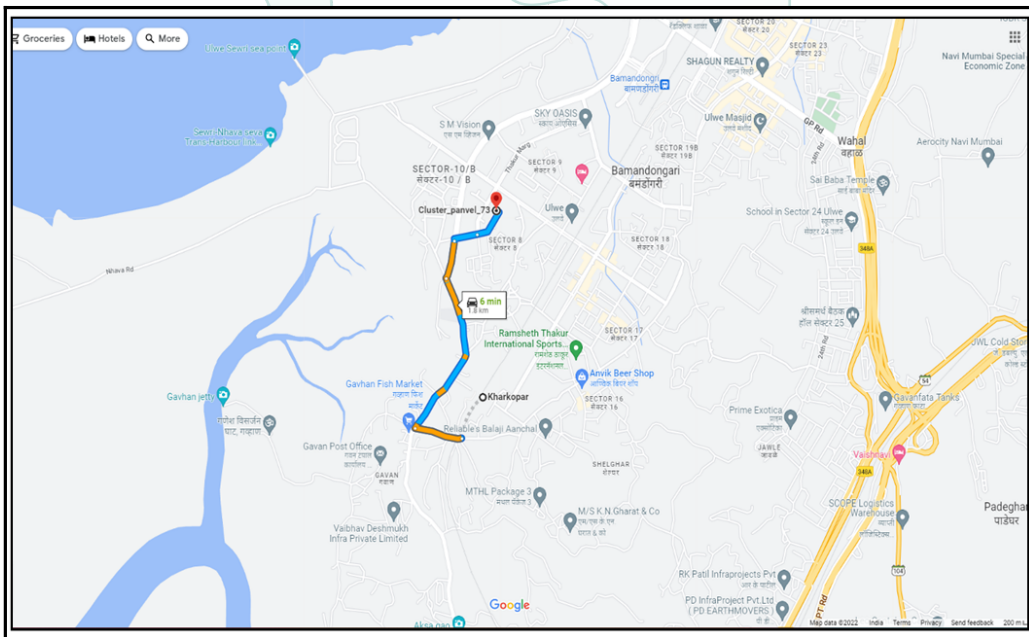




### Route Map of the property

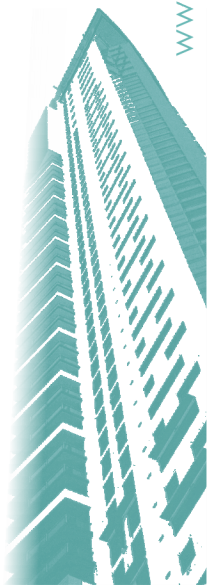


**Note:**Red marks shows the exact location of the property
