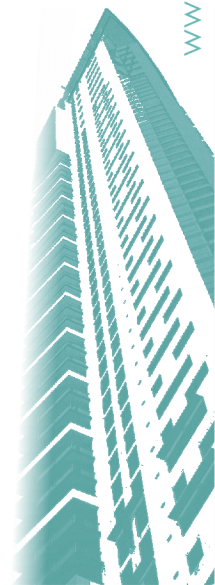

**Note:** The Blue line shows the route to site from nearest railway station (Thakurli - 1.2 KM).

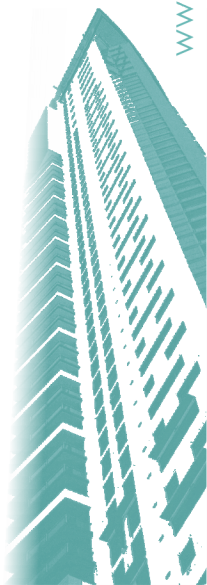
