The sales comparison approach is commonly used for Residential Flat, where there are typically many comparables available to analyze. 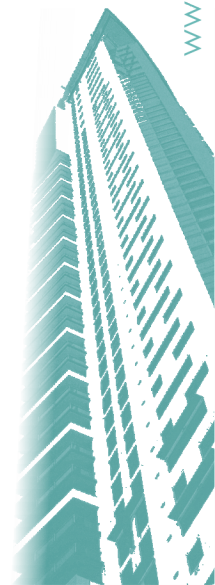

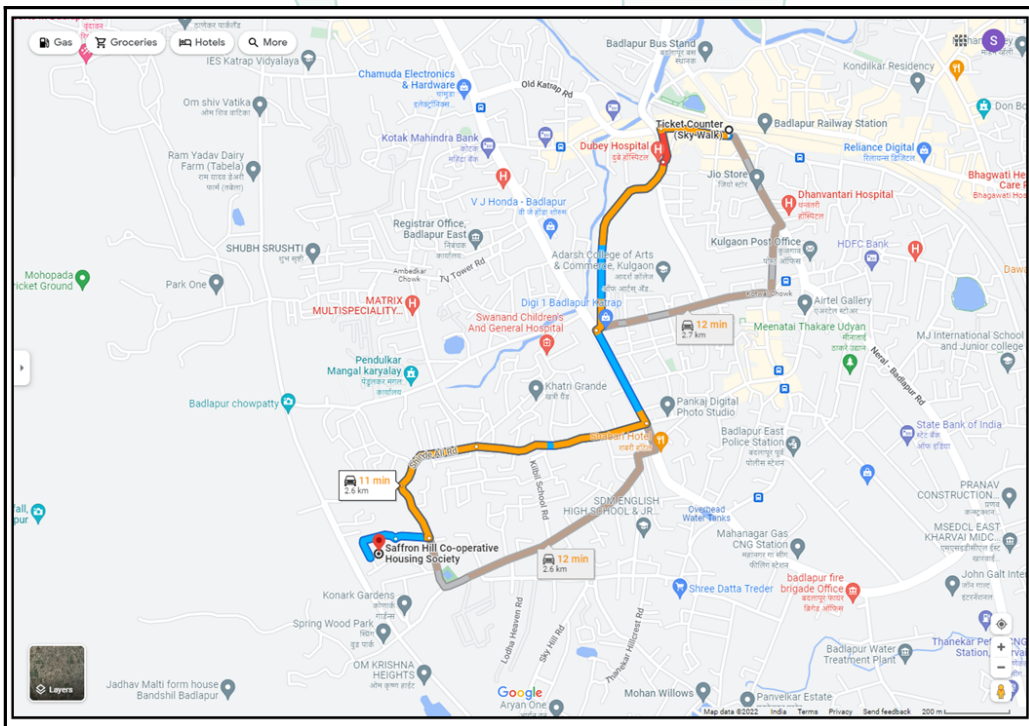
