### Route Map of the property

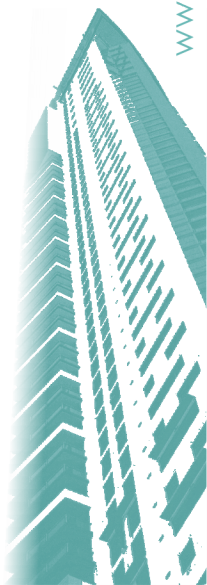


**Note:**Red marks shows the exact location of the property



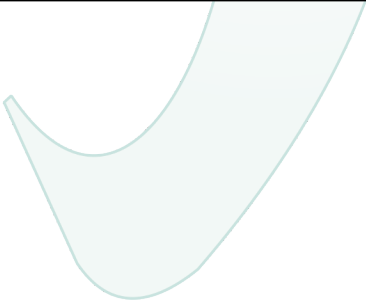

**Note:** The Blue line shows the route to site from nearest railway station (Thane - 7.3 Kms).

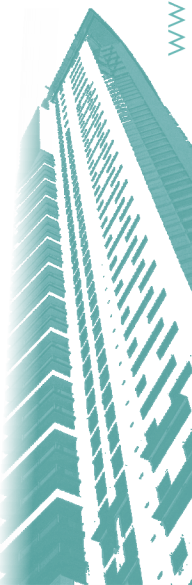
