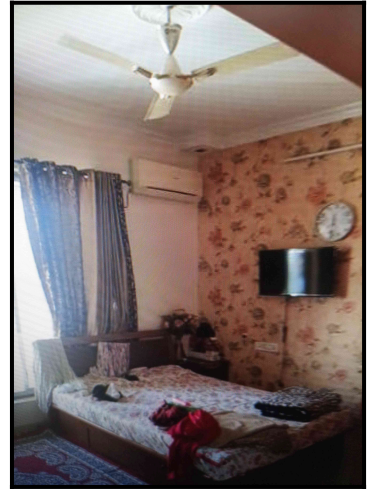

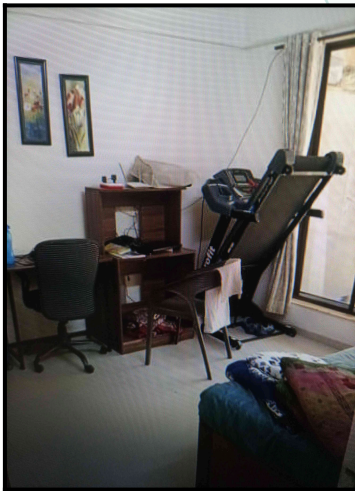

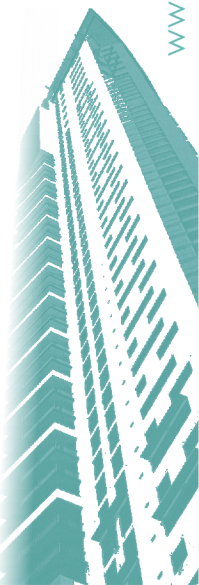

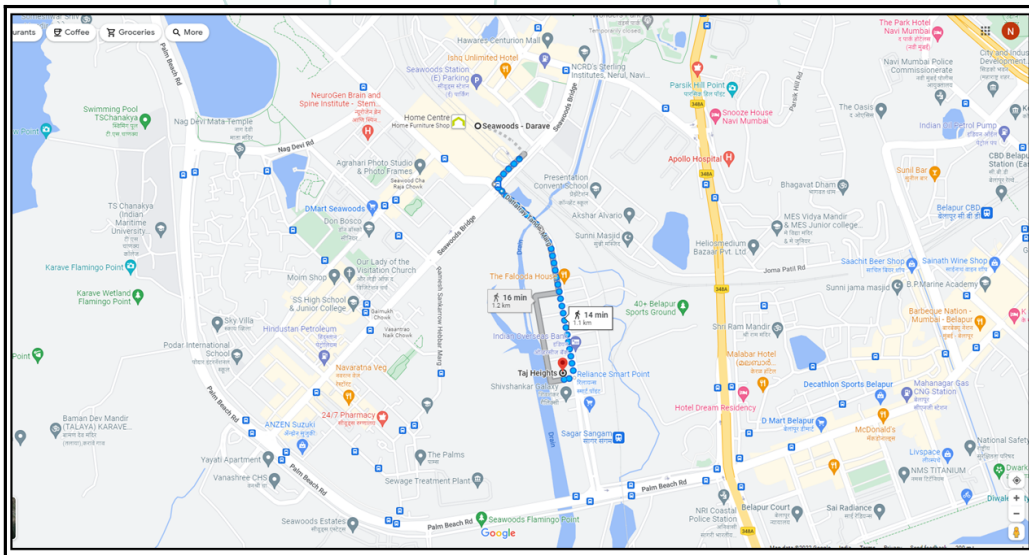

Route Map of the property



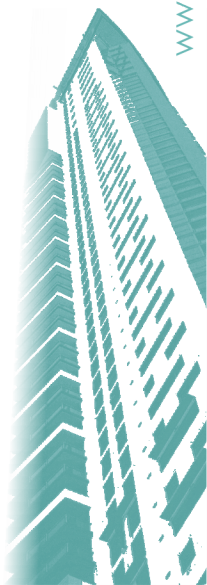
Note:Red marks shows the exact location of the property
