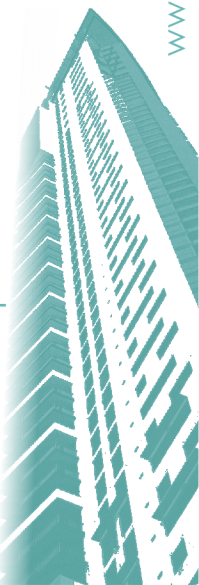

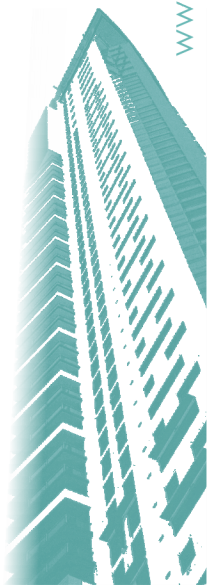

As the property is a Residential Flat, we have adopted Sale Comparison Approach Method for the purpose of valuation. The Price for similar type of property in the nearby vicinity is in the range of ₹ 7,100.00 to ₹ 8,200.00 per Sq. Ft. on Built Up Area. 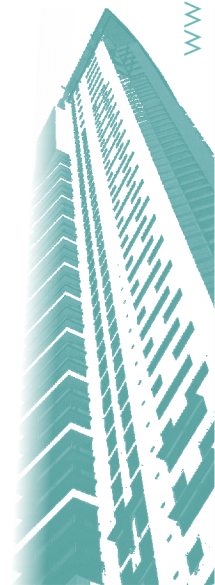

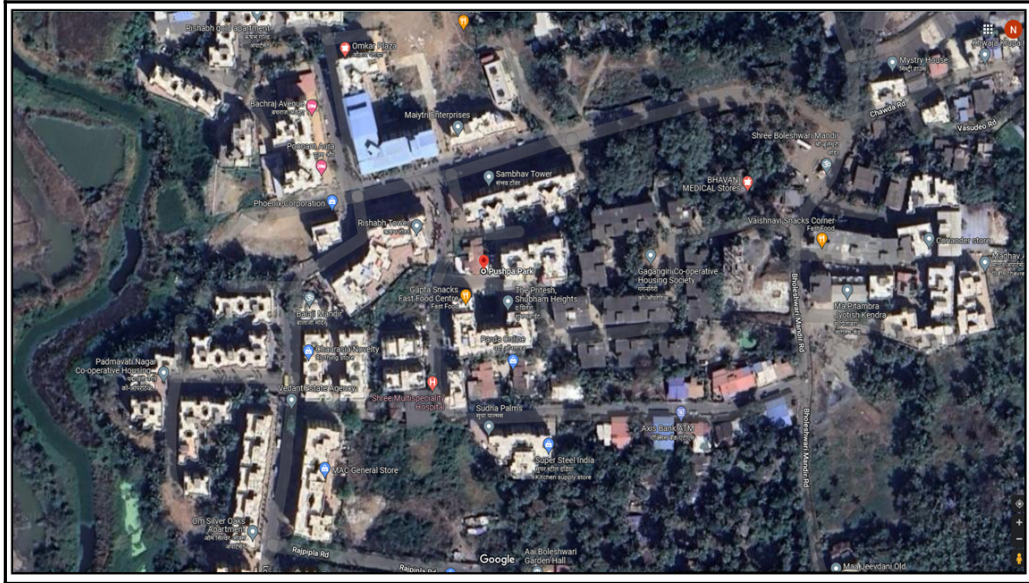

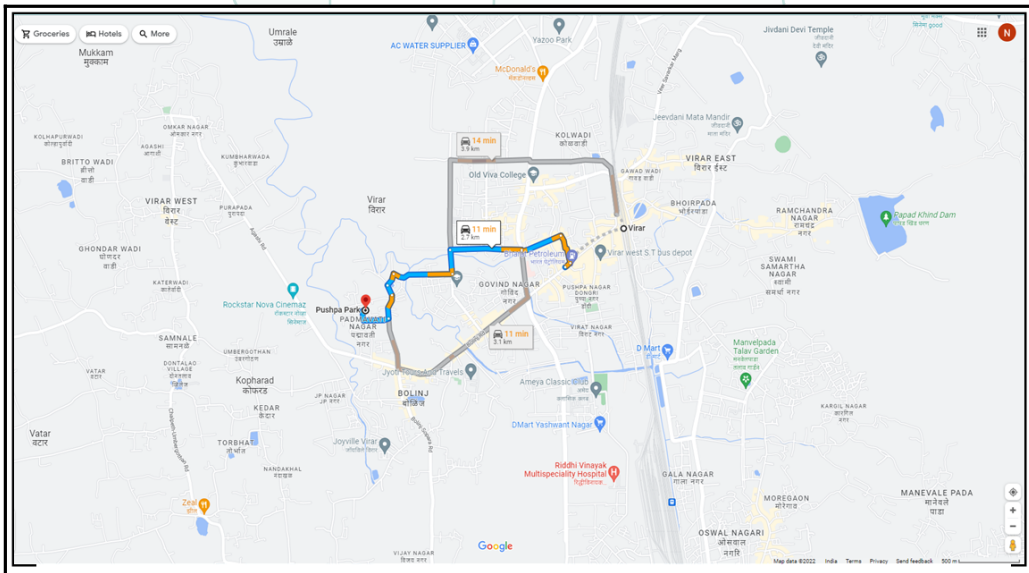

Route Map of the property

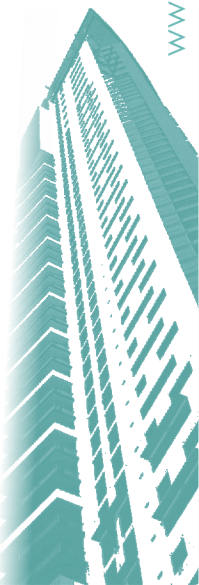


Note:Red marks shows the exact location of the property
