We are of the opinion that the value arrive by us will prove to be correct if an Auction of the subject property is carried out. 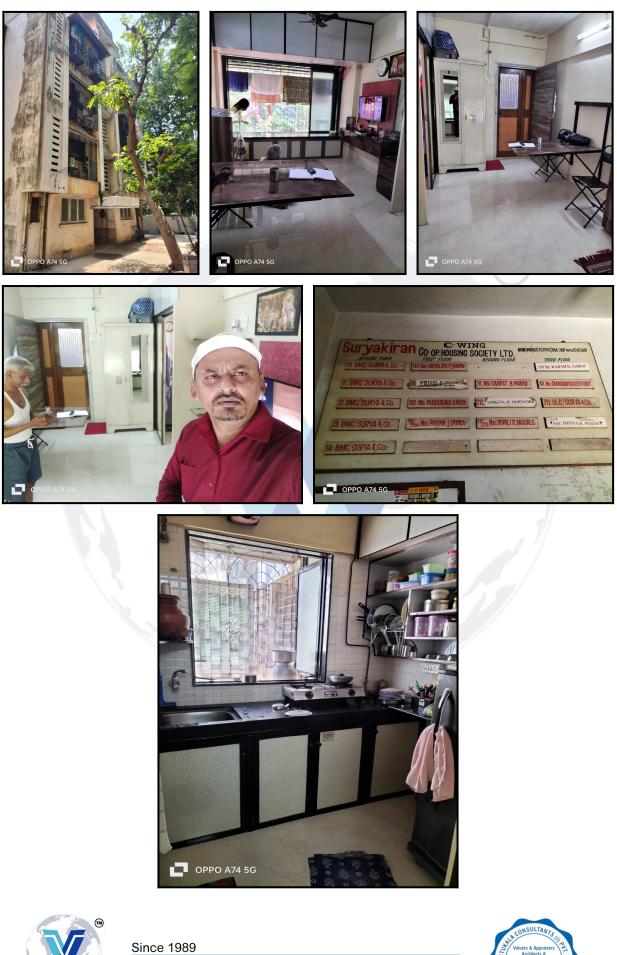

Comparable properties, also known as comparables, or comps, must share certain features with the property in question. 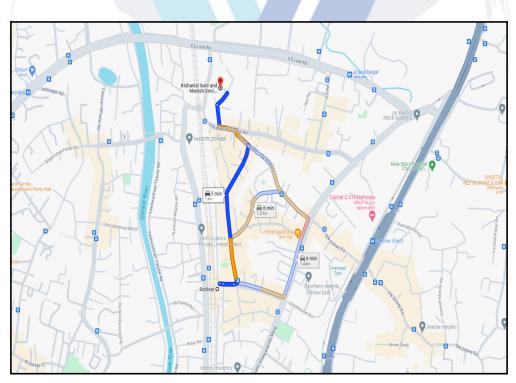
