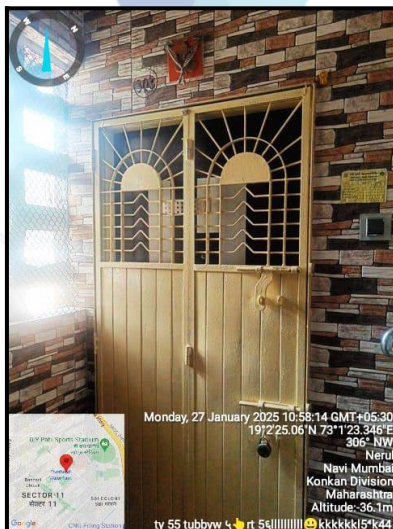
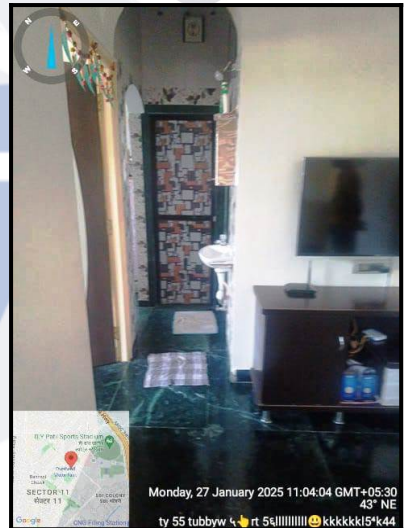
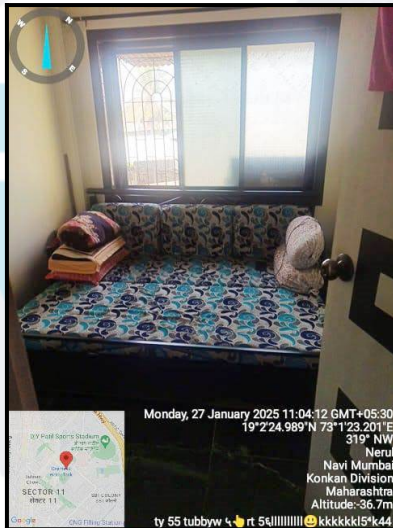

## Method of Valuation / Approach

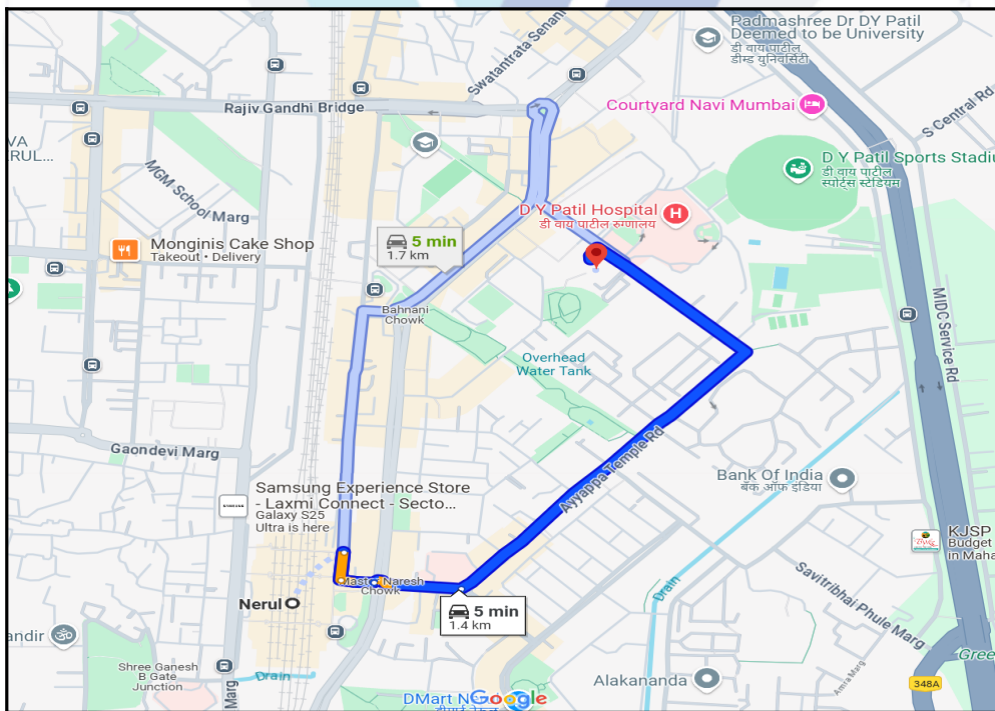


